Course Description This is a three hour first course in Ordinary Differential Equations. Topics include methods of solving ordinary differential equations of first and higher order; systems of linear differential equations; solutions using the Laplace transform; and Fourier series. Mechanical and electrical engineering applications are included. We will meet for lecture three times weekly MWF 10:00–10:50am in D237.
