Course: MTRE 4400 Healthcare Robotics, 3 credits

II. Course Description

This course will explore developing healthcare robotics that function to perform hospitalize tasks that can be used to alleviate work load on physicians and/or staff, provide for patients, or maintain workflow and hospital environment. This will include discussing the perception of mechanized robots in healthcare by users and patients.

III. Objective of the Course

This directed research aims to prepare a manuscript discussing current advances and implementation of robots used in healthcare by polling physicians, staff/personnel and patients on their perception of robots in healthcare to determine if physical appearance and the types of tasks performed by them have an effect on their use. Finally, it will explore developing technology locally that can be used to advance healthcare.

IV. Detailed Schedule

Week 1: CITI training and drafting of questionnaire

Week 2: Obtain hospital or clinic approval for polling and submit IRB application

Week 3: Perform literature review and outline manuscript

Week 4: Begin polling and research available commercial medical robots

Week 5: Compile interview results from companies and academics developing robots for healthcare

Week 6: Begin drafting manuscript

Week 7: Finalize manuscript

The student is expected to work independently on this project, of course under direction of the instructor. Meeting with the instructor is expected at least once weekly, demonstrating completion of the week's task. A minimum total of 150 hours of time is required on this project. The student is expected to follow all safety guidelines when interacting with equipment as directed by instructors and laboratory technicians.

V. Basis for Evaluation

The primary deliverables for this course is a manuscript to be submitted to the Kennesaw Journal of Undergraduate Research. The student will be evaluated on satisfactory creation and distribution of the questionnaires (40%), compilation of a logbook documenting the progress made and time spent (20%), and preparation of a manuscript for publication (40%). Grades will be assigned for each component according to the following rubric:

- A (90-100): Exceptional deliverable quality and/or completion of extended topics
- B (80-89): Satisfactory completion of deliverables
- C (70-79): Incomplete completion of deliverables
- D (60-69): Partial completion of deliverables
- F (0-59): Little or no completion of deliverables
