STS 2105 Social Issues
Science, Technology, and Society
Medical Ethics through Film

Course Description:

This course provides students with the knowledge and tools necessary to critically examine the development and integration of science, technology, and society. The course seeks to help students better understand the world in which they live, the broader implications of their major course of study, and the complex social, ethical, and moral choices presented by modern science and technology.

STS 2105 is an interdisciplinary course designed to help students realize the impact we each have individually and collectively on a local and global scale through science, technology, and society. The goal is to see how decisions, educational, professional, social, and personal, affect the complex social, ethical, and moral choices of a modern technologically and scientifically advancing world. Through discussions and assignments in bioethics, morality, ethics, ethical theory, professionalism, and case studies, this course is designed to help students evaluate all sides of environmental disaster ethical dilemmas and to be able to express and defend their own position in these and other issues.

Learning Outcomes:

At the end of this course, students will be able to:

1. Identify and evaluate competing views and the information supporting them.
2. Formulate their own opinions on complex issues and to communicate their views clearly in both written and oral formats, and support their position with relevant evidence.
3. Recognize the ways in which science and technology have been shaped by, and have helped to shape, society, and culture.
4. Apply STS concepts to the scientific disciplines and technologies relevant to their majors.
5. Participate effectively in multidisciplinary groups.

Grading:

I will make every effort to return your papers as quickly as possible. Although this is not an English class, grammar and spelling do count. **Proofread** your work carefully and **never rely** on computer programs to perform that task completely for you. If you have questions about your grades, do not wait until the end of the term to ask. Bring any questions you have to my attention as soon as possible after you receive your grade. Waiting may cost you the ability to argue on your behalf. I do not curve grades and generally do not round up since I offer very generous extra credit. Extra credit is voluntary but highly recommended.

You can earn points through a variety of ways:

1. **Participation** – 75 total points possible – Much of this course is taught through class participation, which requires your mental and physical attendance. Class discussions, case studies, role-plays, group activities, etc. all contribute to the environment where students will actively learn and also provide learning opportunities for others around them. **Students are solely responsible for managing their enrollment status in a course; nonattendance does not constitute a withdrawal.** Rather than penalizing those who do not attend class, I will be rewarding those who do. For each of 15 weeks that a student attends, the student will receive 5 points for a total of 75 participation points. Students who are absent because of participation in approved University activities such as field trips, athletic events, etc., will be permitted to make up the work missed during their absences. The instructor will grant approval of such absences **only with advance notice in writing** and only if the student makes up the work in a timely manner. Other circumstances may be forgiven on a case-by-case basis but only for extreme reasons. We all make choices everyday and must accept the consequences of that decision. **It is the student's responsibility to ensure the professor receives the necessary paperwork to grant participation points for a missed class.**
REMEMBER - Ethics discussions will touch on personal issues for most if not all of us. Classroom conversations must remain academic in nature and never become personal attacks directed toward an individual, their profession, their beliefs, their religion, their culture, etc. Keep in mind it is the discussion element that provides the alternative viewpoints that challenge/strengthen your point of view. You can get no more out of the class discussion than you are willing to put into it and your classmates learn nothing from those who remain silent.
2. **Written assignments/activities** – 75 points possible – You will be required to submit **three** written assignments. Directions for each assignment are posted in the drop box in D2L. **Written assignments are due as assigned in your D2L calendar and must be received in the dropbox by 11:59 PM. I do not accept late papers for grading purposes without valid reasons.** In addition, we will have in class activities for which you can receive credit in place of a written assignment. These activities require attendance and cannot be made up.
3. **Group project** – 50 points possible – This is an interdisciplinary project requirement, meaning each member must be from a different field of study or major program. I will help divide the class into groups according to their respective majors. Groups must present final projects in some electronic form viewable by all students for peer review. See instructions posted below.
4. **Midterm** – 50 points possible – You will be provided a terminology handout as a study guide. **Your midterm vocabulary quiz is based on the terminology handout provided in D2L.** The midterm will be taken online during the week of February 8th through February 15th.
5. **Quizzes** – 50 total points possible – These are short quizzes designed to test your knowledge in several areas including the syllabus, academic honesty, bibliographies, and APA/MLA citations. You will have unlimited attempts over a four week period to achieve 100% for these quizzes. Information for the bibliography and citation quizzes will be provided in the quizzes in D2L. **Pay careful attention to the due dates of your quizzes. They are located in D2L.**
6. **Extra Credit** – 30 points possible – This is limited to 10% of the total points available throughout the semester. Keep in mind 10% is the opportunity for an entire letter grade if

you need it or an extra cushion if you do not. Choosing to participate is entirely **your decision**. Instructions for extra credit opportunities are posted below. You may combine any of the extra credit opportunities to reach a maximum of 30 points or you may complete all of your extra credit in one category. **Email all submissions to me by midnight on the last day class (not the last day of final exams).**

Written Assignment Instructions:

Medical Ethics issues easily have two or more sides, many representing professionals, clients/patients, their families, and sometimes the law or court. For these assignments (unless instructed otherwise), you are required to **present the issues on the pro/for side with supporting evidence documented from your textbook, present the issues on the con/against side with supporting evidence, and then defend your own personal position on the issues by citing supporting evidence.** **Supporting evidence must come from your textbooks unless otherwise stated and must be documented in correct APA or MLA citation.** Papers require an annotated bibliography. The written assignments must be **typed and double-spaced**. Your name and page number must appear **only in the header** of all pages to identify each page of your paper.

Written assignments are due as assigned on D2L. I do not accept late papers for grading purposes without valid reasons. If a student expects to be unavailable on the due date, to receive full credit for the paper, submit the paper before it is due via the D2L dropbox. Ask questions regarding papers **before** the assignment due date unless the question is about a grade received.

Final Group Project Instructions:

This is an interdisciplinary project requiring each member to be from a different field of study or major program. Each group will consist of approximately 4-5 students (meaning 8-10 projects total). The project will be broken down into a few steps to facilitate both individual and group progress on the project. The final project must be presented in some electronic form that can be viewed by all students for peer review.

1. Each student is required to submit two working links of their professional code of ethics from their intended occupation or field of study, one from the United States and one from another country. This submission must have a valid source included such as book title, magazine, working link, etc. Either way, I should be able to get back to your information. If you do not know where to look, try a Google search for your professional organization and the words "code of ethics" (for example – American Medical Association code of ethics) or simply ask me. If you do not know what your professional organization is, search your profession and the words "professional organization" such as engineer professional organization or accountant professional organization and you will see several options. Begin your search early just in case and remember to talk to me if you have any difficulties. **Submit these links to your assigned group project discussion thread**

NO LATER THAN midnight on January 25th. This is an individual step required of all students.

2. This step involves each student reviewing both codes of ethics/conduct for their field and listing the specific ethics from each that are not applicable to any and almost every profession. If you think the specific ethics apply only to your field, tell me which ones and the reason why. If you think the entire code is generic, just simply state that in your private group discussion thread. Some of you will actually find this is the case. Ask me if you do not understand this assignment, as it is an important part of your group project. **This assignment must be submitted NO LATER THAN midnight on February 8th.** This is an individual step required of all students. You will use these deliverables from each group member to begin building your group project.

Group structure may change after the final class withdrawal date. This is simply another challenge to meet head-on. If you have any questions regarding your group, contact me if or when they occur.

3. The group is responsible for taking the professional ethics from each member with the input of step two and together rewriting **one** set of professional ethics that could be used for **any profession anywhere**. You must go beyond the no lying, no stealing, be nice to your customers philosophy. You must incorporate professional codes of ethics from international organizations in the final project. How you do that is up to the group, but I must be able to see incorporation of international ethical elements in the final product.
4. The final product will be in the form of an electronic presentation with the format selected by the group. Each presentation must incorporate the work of all members and last between 4-7 minutes. Create your own training scenario for employees. Maybe you are giving this presentation to your bosses and your peers in an orientation environment. Maybe you need to improve relations between employees and customers. On the other hand, maybe you are teaching everyone to be accountable and to hold each other accountable for their actions. You decide; it is your presentation. Use the project grading rubric as a guide to make sure your project addresses all required elements.

Your group must also decide on the choice of medium to present the final project. It might be power point, role-play, videotaping, a tool found on the Internet to create projects (ex. Prezi), or even animation software (ex. PowToons). Use your imagination. Use color, use sound, use whatever seems visually appealing or appropriate to keep the attention of your audience and get your message out. Let your creativity shine, but remember the grading criteria listed on the evaluation sheets in this syllabus! That is how you, your classmates, and I will grade your project so build the project with those considerations in mind.

5. **By midnight on March 20th**, each group is required to submit the final projects to me via email (tqueen4@kennesaw.edu). I will upload the projects to D2L exactly as they were provided to me. The projects will be visible on the homepage after I receive and repost all of the projects.
6. Lastly, you must complete the group review sheets (**grade yourselves, your project, and your group members**). **Failure to submit your own review sheet results in a grade of 0 for your individual evaluation. Failure to participate in the project results in an overall grade of 0 for the group project.** Learning to evaluate your peers and yourself honestly is

an important skill you will use throughout your career whatever field you choose. You must also view the other projects after I post them on our D2L home page and complete the review sheets for each group. **Review sheets must be posted in the dropbox and are due no later than midnight on April 3rd.**

Your final project scores are comprised of the average individual score received from you and your group members (for a total of 10 points possible), average of the group score received from the class (20 points possible), and my grade for your group project (20 points possible) for a total of 50 points. If you do not participate in the project at all, you will receive a zero for the entire project. This is a required component of all STS 2105 sections.

Extra Credit Instructions:

1. The Do-it-yourself Field Trip

Take yourself on a field trip for this course! You may visit any location or event related to our class (ask me for suggestions or approval if you are unsure), but you must be able to meet the requirements of the assignment. You are encouraged, but not required, to visit some place you have never been before. Make it fun! Take your friends or family or organize a group from class to do something together. You can go to a place or to an event. Visit an institution, attend a lecture, or see an exhibit. It has to be real time/real space—not cyberspace.

How much credit?

You may do **two** field trips per course per term, and may earn a maximum of 5% (15 points) for each trip toward your final grade.

To get your credit, you must submit the following things no later than one week prior to the last day of this term:

(1) Provide proof of the date of your visit—which must be during this semester. This proof might be a ticket, a receipt from the gift shop, a flyer from a one-time event. Whatever it is, it has to have printed on it the name of the event / institution and the DATE.

(2) Type a 1- to 2-page essay explaining where you went, why you chose it, and what you learned that applies to medical ethics. If this essay does not make clear how the visit relates to the course, you will not get extra credit. (If in doubt, you can always check with me ahead of time.)

2. Related movie, book or game review

Watch a movie! Rent it, buy it, or borrow it. Get together and watch the movie with your friends or your family. Have some popcorn and earn extra credit points. Submit a written review and earn 2% (6 points) of your final grade for each movie reviewed up to the maximum extra credit points.

To get your credit, submit a 1- to 2-page essay explaining what you saw, the ethical issue(s) involved, and your position on the issue(s). If this essay does not make clear how the movie relates to ethics, you will not get extra credit. (If in doubt, you can always check with me ahead of time.) Remember, typing is required!
